DECLARING CERTAIN ACTS AGAINST THE GOOD ORDER AND GOVERNMENT, HEALTH AND CLEANLINESS OF THE BOROUGH TO BE UNLAWFUL, PROHIBITING THE SAME AND PROVIDING PENALTIES THEREFOR.

Estit ordained and anacted by the Eorough Council of the Eorough of Lyons, and it is hereby ordained and enacted by authority of the same, that it shall be unlawful for any person, firm, corporation or association within the limits of the Eorough of Lyons:

Section 1. To make wilfully, or cause or permit to be made, any loud, boisterous, or unseemly noise or disturbance to the annoyance of the residents nearby.

Section 2. To loaf, loiter, or stand upon or otherwise occupy any of the sidewalks, streets, crossings, street corners, bridges, highways or alleys so as to interfere with or obstruct the free passage of citizens or travelers along the same.

Section 3. To loaf, loiter or stand unnecessarily and without the consent of the owner thereof upon the steps, porticos, railings or fences of any private property.

Section 4. To be in an intoxicated condition on any of the sidewalks, streets, crossings, street corners, bridges, highways, or alleys within the borough.

Section 5. To engage in any indecent conduct or harrass any persons with abusive, vile or profane language on any of the sidewalks, streets, crossings, street corners, bridges, highways, or alleys within the Borough

Section 6. To drive any vehicle of any type whatsoever, on any alley, street, bridge or public passageway in violation of any sign or barrier prohibiting or controlling the passage of any vehicle or limiting the weight of any vehicle.

Section 7. To make any bonfire or bonfires, or to set fire to any wood, shavings, paper, hay, straw, or any other infibatimable substance on any public street, lane or alley.

Section 8. To cause or allow dense smoke to issue or to be emitted from any smokestack or chimnney or other flue of any dwelling house or other building to the harm or annoyance of residents nearby.

Section 5. To nail, tack, hang or otherwise append any sign, notice or advertisement of any kind whatsoever upon any tree, post, pole, electric pole or pillar of any description, except on private property and then only by permission of the owner thereof, unless done by a public officer legally authorized.

Section 10. To keep or scatter or suffer to remain on any premises any odorous, offensive or unwholesome matter of any kind, or any wood, corncobs or other matters or substance or substances which attracts rats, mice or other rodents or insects.

Section 11. Any person, firm, corporation or association violating any of the provisions of this ordinance shall, upon conviction before the Mayor or any Justice of the Peace of the Eorough of Lyons, be sentenced to pay a fine not less than \$30.00

Section 12. That all of the proceedings for the violation of borough Ordinances and for the collection of fines and penalties imposed thereby, may be commenced by warrant or by summons at the discretion of the Mayor or Justice of the Peace before whom the proceedings are commenced, but no warrant shall be issued except on oath or affirmation specifying the Ordinance for the violation of which the same was issued, and all process may be directed to and be served by any policeman or constable of the

Borough, who may execute the same anywhere within the Commonwealth.

Section 13. The invalidity of any portion of this ordinance shall not affect the validity of any other portion thereof, which can be given effect without such invalid part.

Section 14. Any ordinance or parts of ordinance inconsistent herewith including all of Ordinance No. 11 are hereby repealed.
